The Bowls Tasmania constitution provides the following regarding this position:

17.1 Elections

- (a) Elections shall be conducted in such manner and by such method as may be determined by the Board from time to time provided that they comply with this rule 15.
- (b) Each Regional Authority shall be entitled to elect two (2) elected Directors and such elected Directors shall be elected by the Regional Authority located within each region.
- (c) If there are insufficient nominations received to fill a Regional Authority's elected Director position(s) the positions will be deemed casual vacancies under rule 19.1.

19. VACANCIES ON THE BOARD

19.1 Casual Vacancies

Any casual vacancy occurring in the position of Director may be filled by the remaining Directors from among appropriately qualified persons as nominated by the Regional Authority that was entitled to elect the Director whose office has become vacant. Where the relevant Regional Authority cannot identify an appropriately qualified person, the remaining Directors may identify and appoint an appropriately qualified person. Any casual vacancy may only be filled for the remainder of the Director's term under this Constitution.

Accordingly, in the first instance Bowls North and Bowls North West are entitled to nominate one or more persons to fill these vacancies.

Elected Directors previously elected whose terms expire in the future are:

Bowls North - Female – Jane Pickett

Bowls South - Male - Bernard Knight, Female - Anne Mullavey

Bowls NW - Male - Phil Prouse
